1. The **Uganda Railways Corporation** has allocated funds to be used for the acquisition of **Four (4) Brand New Double Cabin Pickups – Lot 1 and Five (05) Motor Cycles – Lot 2**
2. The Entity invites sealed bids from eligible bidders for the provision of the above supplies.
3. Bidding will be conducted in accordance with the open **Domestic** bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003 (As Amended), and is open to National and Resident Providers in accordance with PPDA Guideline of 2018.

The method of payment will be **CASH payable to the Chief Cashier, Room 5, First Floor, Headquarters Building, Plot 57, Nasser Road, Kampala, Uganda. The payment receipt issued by the Chief Cashier will be presented to the Senior Procurement Officer at the address indicated in 8(a) below to obtain the bidding documents**.

All bids must be accompanied by a bid security of **UGX8.5million for Lot 1, and a bid securing declaration for Lot 2**.
