1. The **Uganda Railways Corporation** has allocated funds to be used for the acquisition of **Special Tools – Lot 1 and additional spares – Lot 2 for 98 Class Diesel Electric Locomotives.**
2. The Entity invites sealed bids from eligible bidders for the provision of the above supplies.
3. Bidding will be conducted in accordance with the open international bidding method contained in the Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
4. Interested eligible bidders may obtain further information and inspect the bidding documents at the address given below at 8(a) from **8:00 am to 5:00 pm Mondays to Fridays except public holidays.**

The Bidding documents in English may be purchased by interested bidders on the submission of a written application to the address below at 9(b) and upon payment of a non-refundable fee of **UGX 150,000 (Uganda Shillings One hundred Fifty thousand Only).** The method of payment will be **CASH payable to the Chief Cashier, Room 5, First Floor, Headquarters Building, Plot 57, Nasser Road, Kampala, Uganda. The payment receipt issued by the Chief Cashier will be presented to the Senior Procurement Officer at the address indicated in 8(a) below to obtain the bidding documents.**

Bids must be delivered to the address below at 8(c) at or before **3:00 pm (local time) on July 22, 2022.** All bids must be accompanied by a bid security of **UGX2,000,000 for Lot 1 and UGX16Million for Lot 2.** Bid securities must be valid until **January 20, 2023.** Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **3:15 pm (local time) on July 22, 2022.**
