The Government of Uganda, represented by the Uganda Railways Corporation (URC) has received financing from the African Development Bank toward the cost of the refurbishment of the Kampala – Malaba Meter Gauge Railway, and intends to apply part of the agreed amount for this loan to payments under the contract for the Provision of Consultancy Services for the Implementation of the Resettlement Action Plan. The project will be implemented by the URC.

The Resettlement will be undertaken along the Tororo/Malaba - Kampala line, Kampala-Port-Bell section and Kampala-Kyengera line covering a number of districts, sub counties and villages both in Rural and urban areas.

Uganda Railways Corporation now invites eligible consultants to indicate their interest in providing these services. Interested consultants must provide information indicating that they are qualified to perform the services (brochures, description of similar assignments, experience in similar conditions, availability of appropriate skills among staff, etc.). Consultants may constitute joint ventures to enhance their chances of qualification.

Eligibility criteria, establishment of the short-list and the selection procedure shall be in accordance with the African Development Bank's *"Procurement Policy for Bank Group-Funded Operations"* approved October 2015, which is available on the Bank's website at www.afdb.org.
